

PHOTOGRAPHY & VIDEOGRAPHY POLICY

Please review the photography and videography information available at https://www.dixon.org/photography-policy before scheduling a photo shoot. All shoots must be scheduled.

- All shoots must take place during regular museum hours. The Dixon is open to the public Tuesday through Saturday, 10am to 5pm and Sundays, 1pm to 5pm; on the third Thursday of every month, the Dixon is open late, until 8pm. The Dixon is closed to the public on Mondays. Availability may vary based on events and other activities on property. The latest a shoot may be scheduled is 4pm (or 7pm on Third Thurs.) to ensure groups are done and out by closing time.
- Wedding portraits of any kind, *excluding* engagement photos, for non-Dixon weddings are not allowed on days when a Dixon wedding is scheduled.
- All use of photography/video taken at the Dixon for promotional or commercial use must credit Dixon Gallery and Gardens. Please tag the Dixon and/or include the Dixon as a location when posting photos on social media.
- Pets, excluding service animals, are not allowed on property and may not be used in shoots.
- Photographers/videographers and their guests must use pathways and grassy areas when traveling
 the property and posing. No posing/standing/sitting on statues or garden structures or in flower
 beds, staff-only areas, or anywhere that is clearly not a pathway or open green space. No outdoor
 exhibitions, plants, furniture, or equipment can be removed, moved, altered, or covered.
- Shoots may only take place in the gardens (and Conservatory greenhouse, as space allows); they are not allowed inside any buildings.
- The Dixon does not provide spaces for guests to change clothing or do hair/makeup. If you have questions about this, please include this in your photo scheduling inquiry.
- Participants involved in shoots must dress and pose appropriately—no excessive displays of skin, no changing outfits in the gardens/in public, and no suggestive poses. The Dixon reserves the right to end shoots if deemed inappropriate.
- Please be aware of and respectful of museum visitors as well as other photography/video shoots while on property. Do not block pathways and garden areas for long periods of time.
- No "pop-up" wedding ceremonies allowed during photography/video shoots. Please contact the Venue Rental Coordinator to schedule your special event.
- Please be aware that Dixon plantings and outdoor exhibitions are subject to change throughout the year and the Dixon is not responsible for how this may impact your shoot.
- Drones and similar technology must be approved in advance and approval is not guaranteed.
- Props and backdrops must be approved in advance and approval is not guaranteed.
